- 2. The Order shall be subject to the outcome of SLP (C) No. 30621/2011 (Jarnail Singh and others Vs. Lachhmi Narain Gupta and others), the outcome of OA No.555/2023 filed before the Hon'ble CAT, Patna by Neeraj Xavier Kullu & Ors. Vs. the Union of India & Ors. and all other litigation pending on the issue of seniority/promotion and other related matter before any judicial forum.
- 3. The Inter-se-seniority of the above promoted officers will be decided separately.
- 4. The promoted officers should exercise option for fixation of pay in terms of FR 22 (I)(a)(1) within one month from the date of joining as Superintendent and option once exercised will be final. However, if any officer has already been granted financial up-gradation under MACP Scheme then he would not be entitled for any fixation benefit.
- 5. The officers being promoted through this Order shall assume the charge of the post of the Superintendent in the same office where they are currently posted, till their posting in the promotional grade is decided.
- 6. The Controlling officer shall ensure that if any officer whose name figures in this Estt. Order is under suspension or facing any charge-sheet or prosecution, he should not be allowed to assume charge of the post of Superintendent and this fact should be reported to this office immediately. Further, if any officer figuring in this Estt. Order is undergoing any penalty; he should be allowed to assume charge of the post of Superintendent only after expiry of the currency of the penalty period. This fact should also be reported to this office.
