- 4. The promoted officers should exercise option for fixation of pay in terms of FR 22 1(a)(i) within one month from the date of joining as Inspector. Option once exercised will be final. However, officers who have already been granted financial up-gradation under ACP/MACP Scheme are not entitled for any fixation benefit now.
- 5. This order shall be subject to the outcome of the O.A. No. 438 of 2020 in the case of Binod Kumar Jha Vs. UOI and Ors. or any other litigation pending on the issue of seniority/promotion and other related matter before any judicial forum.
- Officer being promoted in this order shall assume the charge of the post of the Inspector in the 6. same office where he is currently posted at this stage till AGT.
- Commissioner shall ensure that if the officer whose name figures in this Estt. Order is under 7. suspension or facing any charge sheet or prosecution, he/she should not be allowed to assume charge of the post of Inspector. Further, in case any officer is undergoing a penalty, he/she should be allowed to assume charge of the post of Inspector only after expiry of the currency of the penalty period. Such facts be reported to this office.
