  - 4. The promoted officer should exercise option for fixation of pay in terms of FR 22 1(a)(i) within one month from the date of joining as Head Havaldar. Option once exercised will be final. However, the officer already been granted financial up-gradation under ACP/MACP Scheme is not entitled for any fixation benefit now.
- 5. This Order shall be subject to the outcome of any litigation pending on the issue of seniority/promotion and other related matter before any judicial forum.
- 6. Officer being promoted in this Order shall assume the charge of the post of the Head Havaldar in the same office where he is currently posted at this stage.
- 7. Commissioner shall ensure that if the officer whose name figures in this Estt. Order is Under Suspension or facing any Charge sheet or prosecution, he/she should not be allowed to assume charge of the post of Head Havaldar. Further, in case any officer is undergoing a penalty, he/she should be allowed to assume charge of the post of Head Havaldar only after expiry of the currency of the penalty period.
