- 2. Compliance report regarding joining/non-joining in respect of officers promoted should be sent to this office by 15.11.2021 positively by the respective Commissioner.

- 4. The promoted officer should exercise option for fixation of pay in terms of FR 22 1(a)(i) within one month from the date of joining as Superintendent. Option once exercised will be final. However, officer who has already been granted financial up-gradation under ACP/MACP Scheme is not entitled for any fixation benefit now.

- 6. The officer getting promotion during posting in Customs Patna, will be repatriated to Cadre Controlling Authority i.e. CGST & CX., Patna immediately as per Zonal Transfer Policy, 2020.
- 7. Commissioner shall ensure that if the officer whose name figures in this Estt. Order is under suspension or facing any charge sheet or prosecution, he/she should not be allowed to
