- 2. \*The promotion of Syed Anwar Ali is in officiating capacity (ad-hoc basis) in terms of Para-2.1 of DoPT O.M. dated 14.09.1992 against sealed cover of an officer in UR category. His regularization will be considered when vacancy becomes available.
- 3. Necessary compliance report regarding joining/non-joining of officers promoted should be sent to this office by the respective Commissionerate within two weeks of issuance of this order.
- 4. The Inter-se-seniority of the above promoted officers will be decided separately.
- 5. The promoted officers should exercise option for fixation of pay in terms of FR 22 (i)(a)(1) within one month from the date of joining as ASI (Weapons) and option once exercised will be final. However, the officers who have already been granted financial up-gradation under ACP/MACP Scheme are not entitled for any fixation benefit now.
- 6. The Order shall be subject to the outcome of any litigation pending on the issue of seniority/promotion and other related matter before any judicial forum.
- 7. The officers being promoted through this Order shall assume the charge of the post of the ASI (Weapons) in the same office where they are currently posted, till their posting in the promotional grade is decided.

8. The Controlling Officer shall ensure that if any of the officers whose name figure in this Estt. Order, is under suspension or facing any charge sheet or prosecution, he should not be allowed to assume charge of the post of ASI (Weapons) and this fact should be reported to this office immediately. Further, if any of the officers figuring in this Estt. Order is undergoing any penalty; he should be allowed to assume charge of the post of ASI (Weapons) only after expiry of the currency of the penalty period. This fact also may be reported to this office.
