- The Order shall be subject to the outcome of SLP (C) No. 30621/2011 (Jarnail Singh and others Vs. LachhmiNarain Gupta and others) and O.A No. -----of 2023 (Neeraj Xavier Kullu&Ors. Vs. the Union of India &Ors.) and all other litigation pending on the issue of seniority/promotion and other related matter before any judicial forum.
- Necessary compliance report regarding joining/non-joining in respect of officers promoted should be sent to this office by 18.12.2023 positively by respective Commissionerate.
- The Inter-se-seniority of the above promoted officers will be decided separately.
- The promoted officers should exercise option for fixation of pay in terms of FR 22 (I)(a)(1) within one month from the date of joining as Superintendent and option once exercised will be final. However, if the officer has already been granted financial up-gradation under MACP

- Scheme then she/he will not be entitled for any fixation benefit.
6. In case of unforeseen return of any Superintendent(s) from deputation, if, the working strength of Superintendents in the zone exceeds their sanctioned strength, the junior most officer of that category being promoted vide this order would be reverted to Inspector grade.
  7. The officers presently posted on deputation/loan have to be reverted to their parent cadre for assuming charge of promotional post. On promotion, the joining/taking over charge of such officers in the higher post shall be accepted in the parent zone only i.e. in CGST & CX, Ranchi Zone, Patna.
  8. The officers posted in the Commissionerates on being promoted through this Order shall assume the charge of the post of the Superintendent in the same office where he/she is currently posted, till his/her posting in the promotional grade is decided.
  9. The Controlling officer shall ensure that if the officer whose name figures in this Estt. Order is under suspension or facing any charge-sheet or prosecution, he/she should not be allowed to assume charge of the post of Superintendent and this fact should be reported to this office immediately. Further, if the officer figuring in this Estt. Order is undergoing any penalty; he/she should be allowed to assume charge of the post of Superintendent only after expiry of the currency of the penalty period. This fact should also be reported to this office.


