**Establishment Order No. 67/2025**



Consequent upon recommendation of the DPC in the meeting held on 25.02.2025, the following officer in the grade of Inspector (Group 'B' Non-Gazetted) of CGST & CX, Ranchi Zone, Patna is hereby promoted, to the grade of Superintendent, Group 'B' Gazetted, in Level-8 of the Pay Matrix of Rs. 47,600-1,51,100 (7<sup>th</sup> CPC Pay Matrix) plus other allowances, as admissible, with effect from the date mentioned in the last column against the name of the officer: -

- The promotion of Shri Manoj Kumar (D.O.B.01.03.77) and Md. Kashif Firoj Khan (D.O.B- 31.07.89) is on ad-hoc basis and does not confer any right for any claim for continued officiation or regular promotion in the grade of Superintendent and the period of such service will not count for seniority or as qualifying service for further promotion. The department reserves its right to terminate the ad-hoc promotion and revert the officer to the post from which he has been promoted. His ad-hoc promotion will be considered for regularization when vacancy arises in the UR category in future.
- The ad-hoc promotion granted to Shri Jitesh Kumar (D.O.B.08.06.73) and Sh. Saket (D.O.B.25.10.88) vide Estt. Order No. 50/2025 dated 17.06.2025 and 63/2025 dated 29.07.2025 respectively is regularized w.e.f. 01.09.2025.
- The Order shall be subject to the outcome of SLP (C) No. 30621/2011 (Jarnail Singh and others Vs. Lachhmi Narain Gupta and others), the outcome of OA No.555/2023 filed before the Hon'ble CAT, Patna by Neeraj Xavier Kullu & Ors. Vs. the Union of India & Ors. and all other litigation pending on the issue of seniority/promotion and other related matter before any judicial forum.
- The inter-se seniority of the above promoted officer will be decided separately.
- The officer being promoted through this Order shall assume the charge of the post of the Superintendent in the same office where he is currently posted, till his posting in the promotional grade is decided by the Competent Authority.
